ACT OF LAW

of 27 April 2006

on amending the Act of Law on Counteracting Drug Addiction and the Act of Law on Liability of Collective Entities for Acts Prohibited under Penalty

Article 1.

The Act of Law of 29 July 2005 on Counteracting Drug Addiction (Journal of Laws "Dz. U." No 179, item 1485 and of 2006 No 66, item 469) shall be amended as follows:

- 1) Article 58.2. shall be worded as follows:
- "2. If the perpetrator of the act referred to in paragraph 1 supplies a narcotic drug or psychotropic substance to a minor or incites him or her to use such a drug or substance or supplies substantial quantities thereof to other persons shall be subject to the penalty of deprivation of liberty for a term of 6 months to 8 years.";
- 2) Article 61. shall be worded as follows:
- "Art. 61. Whoever, contrary to the provisions of Regulation EC No 273/2004 or Regulation 111/2005, in order to illegally manufacture a narcotic drug or psychotropic substance manufactures, processes, converts, imports, exports, performs intra-Community purchase, intra-Community consignment or transports in transit through the territory of the Republic of Poland or the territory of another state, purchases, possesses, stores or introduces to trade precursors shall be subject to a fine and the penalty of deprivation of liberty for a term up to 5 years.";
- 3) Article 62.2. shall be worded as follows:
- "2. If the object of the act referred to in paragraph 1 is a substantial quantity of narcotic drugs or psychotropic substances, the perpetrator shall be subject to the penalty of deprivation of liberty for a term of 6 months to 8 years
- 4) In Article 63.
- a) paragraphs 1 and 2 shall be worded as follows:
- "1. Whoever, contrary to the provisions of this Act, cultivates poppy, save for low-morphine poppy, or cannabis plant, save for fibrous hemp, or coca plant
- shall be subject to the penalty of deprivation of for a term up to 2 years.
- 2. Whoever, contrary to the provisions of this Act, collects poppy milk, opium, poppy straw, coca leaves, cannabis resin or cannabis plant, save for fibrous hemp,
- shall be subject to the same penalty.
- b) paragraph 3 shall be appended in the following wording:
- "3. If the object of the act, referred to in paragraph 1, is the crop that may produce substantial quantities of poppy straw, coca leaves, cannabis resin or cannabis plant, save for fibrous hemp, the perpetrator shall be subject to the deprivation of liberty for a term of 6 months to 8 years.";

Article 2.

In the Act of Law on Liability of Collective Entities for Acts Prohibited under Penalty (Journal of Laws "Dz.U." No 197, item 1661 as further amended ⁽¹⁾) in Article 16.1.12 the full stop shall be replaced with a dash and point 13 shall be appended in the following wording:

"13) specified in Article 53, Article 55.1 and 3, Article 56. 1 and 3, Article 57, Article. 58, Article. 59. 1 and 2, Article. 61, Article. 62. 1 and 2, Article. 63, Article. 64 of the Act of Law of 29 July 2005 on Counteracting Drug Addiction (Journal of Laws "Dz. U." No 179, item 1485 and of 2006 No 66, item 469 and No 120, item 826)."

Article 3. This Act shall come into force (2) 14 days following promulgation hereof.
